 - Update current place of work and the higher qualification of all nursing faculty through online (<https://nrts.indiannursingcouncil.gov.in/login.nic>) under NRTS.
 - All students including PBBSc(N) shall be enrolled in the admission module available in the NRTS module.
 - The M.Sc(Nursing) faculty of the institution are required to undergo Simulation Training at the National Reference Simulation Centres at Gurugram.
In this regard, the Indian Nursing Council is conducting two trainings namely i) Simulation training and skill update for midwifery faculty and ii) TRAINING OF TRAINERS ON SIMULATION BASED TRAINING with the duration of 5/6 days respectively at the following centres:
